Rules and Regulations (To be strictly followed by all students)

1. **Minimum Attendance Requirement:**

All students must maintain a minimum of **85% attendance** throughout the course.

2. **Course Duration Extension:**

If a student fails to maintain 85% attendance, the course duration may be extended and its payable monthly (Same course fee) accordingly. The institute will not be responsible for any delay in course completion due to low attendance.

3. **Punctuality:**

Students must reach the institute **before 5 minutes** as per their scheduled batch timing. Repeated late arrivals may lead to disciplinary action.

4. **Student Behaviour:**

Students must maintain **proper behaviour** with faculty members and fellow classmates. Any form of misconduct may lead to cancellation of admission without any refund.

5. **Examinations and Course Completion:**

An examination will be conducted at the end of the course. If a student fails the exam, they will be required to either **reappear for the exam** or **revise the course** before being eligible for certification.

6. **Certificate Issuance:**

Certificates will only be issued to students who have successfully passed the final examination and fulfilled all required conditions.

7. **Certificate Charges:**

- **Computer Course Certificate:** ₹350

- (Charges are to be paid at the time of certificate issuance.)

8. **Registration Fees:**

At the time of admission, a **non-refundable registration fee of ₹250** must be paid.

9. **Non-Transferable Admission:**

Admission is **non-transferable**. A student cannot transfer their admission to another person under any circumstances.

10. **Course Fee Submission:**

Students must submit the course fee within **2–3 days** of the course commencement. Failure to do so may lead to **cancellation of admission**, and the institute will not be held responsible for it.
